## **NOTICE OF ELECTIONS**

### **FOR THE CAREFREE BOARD OF DIRECTORS**

October 1, 2021

Carefree Shareholder,

The Election Meeting for five (5) positions on the Carefree Board of Directors, three (3) for a period of two (2) years each and two (2) for a period of three (3) years each beginning on January 1, 2022 will be held on Sunday, November 14, 2021 in the Clubhouse Auditorium between the hours of 11am and 1pm. Any shareholder wishing to vote at that time must present their Carefree photo ID or their assessment book along with a valid driver's license.

Due to numerous state statute changes recently enacted by the State of New Jersey for common interest community elections such as ours, we have had to make the following changes to our election process:

1. The ballot will now include spaces for write-in candidates equal to the number of Director Positions available for election. You may cast votes in any combination of named candidates and/or write-in candidates up to the number of openings on the Board. Any ballot received with more candidates selected than the number of positions available shall be voided and those votes not counted.
2. Every shareholder has received an Absentee Ballot in this packet for those who are unable to attend the Election Meeting on Sunday, November 14, 2021. If it is necessary to use the absentee ballot it must be returned to the Carefree Office no later than 3:45pm on Friday, November 12, 2021 by the person casting the Absentee Ballot along with the proper Carefree photo ID or their assessment book and a valid driver's license. No absentee ballots will be accepted without the proper photo ID. If you are unable to bring your Absentee Ballot in person due to medical reasons, we will arrange for a member of the Election Committee to pick up the ballot at your home prior to the Election Meeting date.
3. A minimum of 30 days prior to the election, the Carefree office shall send a notice to all shareholders who are not in good standing and thereby ineligible to vote. Such notices will state the reason why the member is not in good standing and the shareholder will be allowed to rectify their standing up to five (5) business days prior to the election.
