## Motion to approval the March 9, 2023 Open Shareholders General meeting minutes, approved.

<u>Nicholas Recanti, President</u>- Spring is upon us, and what better time than to play it forward, reach out to an old friend, help a neighbor or volunteer in our community. All are welcome. We appreciate all our terrific volunteers who assist the Board and provide good will for all our Shareholders and residents.

- Sheds and Fences- The proposed changes are posted on the bulletin board and the Board of Directors will vote on this change at our May 11 2023 Open General Meeting.
- We have had many complaints that people are not picking up after their pets. Please do not leave the bag at the location, you must take it with you and deposit it in your own garbage can.
- Notary Services are available by appointment in the office by calling (732) 349-1050.
- I want to thank our office staff for their hard work and dedication. Some of them are residents of our community, they bring a wealth of experience and knowledge that is helping to improve the functionality of our office and services for the community. In order to protect the integrity of our office, the Board implemented that all employees and volunteers must agree and sign a Confidentiality Clause. This protects our Shareholders and Residents personal files and sensitive corporate information.
- The office has implemented a new procedure for making copies for clubs and committees. When requesting copies from the staff, all club and committee requests must be logged in. The date of the request, your name and contact number, number of copies, date needed and when completed the office will contact you and ensure that your copies are done timely.
- Maintenance is responsible for cleaning the coffee pots, putting them away and mopping the
  kitchen floor after all events. I ask that anyone using the facilities clean up after yourselves, that
  includes wiping down all the counters, put everything you use away and sweep the floor. We
  must all work together to keep our kitchen sparkling.

- As you are all aware, we have been struggling financially and are making necessary changes to save money. We welcome everyone's ideas to cut costs or raise funds necessary to offset capital expenses and our association dues. I cannot thank all the volunteers and my fellow Board members enough who work endless hours and are truly dedicated to the welfare of Carefree. A special shout-out to Mary P. and Sue P and all our other committee Chairs who are hosting many great events which assist in raising much needed revenue for our community. Thank you, thank you, thank you.
- The Board has an open-door policy and welcomes all Shareholders and Resident's concerns, suggestions and complaints. If you don't bring it to the Board, we cannot help you. Get the facts; do not rely on hearsay or gossip. It is our job to promote goodwill and support the community.

Maureen Barbieri, Treasurer- I am going to run through a couple of numbers, all this information will be in your next month's Gazette. Income for our first January- March is \$225, 900 that is our HOA assessments. We are right on target, 25% of the year has elapsed. Other total income was \$32,900 and this includes new home sales, auditorium rentals and the real estate office rent. Total of \$258, 800 which again, is right on target for this quarter income. Expenses for the 1<sup>st</sup> quarter, our insurance premiums arrived in April, therefore we accrued a sum of \$22,000. Lawn cutting has not begun but we accrued \$80,000 this was done in order to balance our Profit and Loss Statement. We are currently in negotiations with Turfmasters to eliminate 2 cuts, hopefully that will save us \$40,000. Office expenses are running under budget, custodian salaries are running right on budget, overall our expenses were \$181,100, leaving a net profit of \$77,700. All these figures will be in detail in the May Gazette. Thank you very much.

#### **SHAREHOLDERS COMMENTS:**

Brenda Russotti- Requested that the October 27, 2022 letter addressed to Raymond Mecca regarding an unsanctioned bus trip he held on December 15, 2022 which was posted on the bulletin board be removed. She felt this letter may have triggered the recent Shareholder complaint Director Mecca disclosed at our March 9, 2023 Open Meeting (approved 3/9/23 minutes). President Recanati quickly responded after Director Mecca's announcement, that the complaint was received by our office and addressed at an Executive Session. The complaint had no merit and the Board took no action, so it was a moot point. Shareholder complaints received by the Board are confidential; therefore, this complaint should never have been disclosed by Director Mecca to the community. Terri LiCausi responded to Ms. Russotti that she is responsible for the bulletin boards and said that it was an oversight and apologized for not removing the letter. President Recanati assured Brenda Russotti that the letter will be removed. The October 2022 letter referenced by Ms. Russotti is hereby recorded into the April 13<sup>th</sup> Open General Meeting Minutes.

Dear Mr. Mecca:

It has been brought to the attention of the Carefree Board of Directors that you scheduled an "invitation only" unsanctioned Christmas bus trip for December 15, 2022 and informed your participants that they are to park their automobiles in the Carefree community parking lot. As the former President of the Men's Club, you had full knowledge of our rules regarding community activities and totally disregarded them. Our Holiday City Carefree Trilogy, **Rules and Regulations, ARTICLE IV, UNSANCTIONED BUS TRIP, pg. 2-9** state "<u>Buses and participants on a trip not run by the community's Clubs or Committees and not sanctioned by the Board of Directors may not use Community property."</u>

The Board of Directors did not author the Carefree Trilogy; however, it is our duty to enforce all our governing documents. You placed the Board and our community in a very difficult position. You intentionally did not request an exception from the Board to our rules. This Christmas bus trip was not offered to the community at large, it was a Mecca invite only event; therefore it is an "Unsanctioned Bus Trip". The Board of Directors does not want to disappoint the many participants that plan on attending, so we voted for a special disposition for this event only and will allow the participants to park their automobiles in our community parking lot at their own risk, however, please ensure that the bus does not park on the community property. In the future, any unsanctioned bus trips will not be granted permission to use community property.

This letter should end any confusion for our Shareholders/Residents regarding permission to park on our community grounds while attending this event. The Board of Directors wishes all attendees a great time.
